

CALL FOR APPLICATIONS FOR THE PROVISION OF RADIO AND TELEVISION BROADCASTING SERVICES (UPDATED)

The Independent Broadcasting Authority (IBA) is a Statutory body mandated to regulate the broadcasting industry in Zambia. Among the functions of the IBA is to grant Radio and Television broadcasting licences.

Pursuant to Section 20 (1) of the IBA (Amendment) Act No. 26 of 2010, the IBA now invites applications for the provision of Radio and Television broadcasting services in different parts of the country. 
